

WINSOR TOWNSHIP BOARD MEETING

April 2, 2019

The regular meeting of the Winsor Township Board was called to order at 4:00 p.m. by John P. Kohr, Supervisor.

Present: Robin Buschlen, Nancy Heck, John P. Kohr, David McCormick, John Walsh, Nick Pavlechek, Fire Chief, Kevin Arndt and Matt Ricker from the Huron County Road Commission.

The Pledge of allegiance was given.

The minutes of the regular meeting of the Winsor Township Board held March 5, 2019 had been mailed to each board member. There being no additions or corrections the minutes were approved as presented.

John Kohr discussed four projects scheduled for 2019 with the Road Commission representatives. He noted that asphalt costs for the projects had increased an average of 35%, to the extent that one project may have to be post-poned. The Road Commission will review it's costs and report back to the township..

A motion was made by Nancy Heck, supported by David McCormick, to approve the March 2019 bills and to authorize payment of the April 2019 bills of \$2,053.20. The motion carried.
